1. Budget

a. FY2014: We're at the 58% mark for the fiscal year. Expenses are at 65% and revenue is at 61%

b. FY2015. Submitted and initially reviewed with the town manager. We made a few minor adjustments (additions and reductions) changing expenses from \$316,131 to \$315,517 (a \$614 reduction). Further adjustments will probably have to be made.
